To Whom It May Concern,

I am writing to you as a professional with 20 years of hands on experience in various positions in the pharmaceutical, health, and financial industries. Over the course of my career I have developed an intimate understanding of numerous intricate details of corporate and manufacturing processes within the pharmaceutical market.

As a senior management consultant, I was responsible for implementation of the FDA 21 CFR 11 Compliance which maintained the integrity of clinical trials and manufacturing data for pharmaceutical research and development processes. My responsibilities included developing an effective approach to protecting electronic clinical trials data from any adulteration.

I also headed information integration projects to accommodate recently permitted by FDA MEGA-trials in which the drug development process was shortened from the standard 10 - 15 years to 1 - 5 years. The shorter interval of research was significantly financially advantageous to the pharmaceutical companies. These shorter trials, however, required a new data integration approach to accommodate massive side effects from not thoroughly tested medications, as well as to provide better legal coverage for liabilities and class action lawsuits.

Now that I have established my credentials and qualifications to speak on the topic, I will share with you the purpose of this letter. I have become aware of a disturbing and concerning medical, moral, and ethical issue which I must bring to the attention of our Jewish community leaders. **Many vaccines contain embryonic stem cells obtained from aborted fetal tissue. According to leading scientists, these stem cells can frequently cause mutations in the DNA of the person who receives the vaccine.**

This phenomenon, whereby foreign DNA fragments can be inserted into the DNA of another individual is called "insertional mutagenesis". Theresa Diesher, the foremost authority on this topic, discovered that embryonic stem cells can insert themselves into adult (somatic) stem cells and permanently alter much of the host DNA. Scientific thought has been that genes do not change and most scientists and doctors are trained with that understanding. Even today, very few are familiar with the way genes have been found to behave and mutate. Yet, for molecular biologists this discovery is well known and has resulted in development of new technologies, including those for vaccines; the universal flu vaccine being developed now relies on insertion of genes which trigger an immune reaction into the DNA of the vaccinee.

The use of embryonic stem cell technology in the vaccine manufacturing process provides a pathway for random foreign "small genetic fragments" (pieces of DNA from one person) to be introduced into another person via injection of a vaccine. According to available research, **these embryonic cell debris fragments are of a small enough size to be readily incorporated into the DNA of the vaccinee's own adult (aka somatic) stem cells.** Up to 60 to 80% of the vaccinee's stem cells may be replaced with the altered stem cells, actually changing the person's own DNA program to that of another person. The scientific data clearly demonstrates that such "random" DNA modifications or mutations are inherently dangerous. **Specifically, it can introduce diseases**

**from one person into another and DNA changes to their germ cells (sperm or eggs). This essentially causes personality changes and disorders as well as health defects to be passed on to the next generation.**

Currently, there are two cell lines being used to grow antigens for vaccines, a male line, and a female line. (There are more being developed as I write this.) **DNA fractions from the female line can cause males to develop female tendencies, characteristics and behavioral patterns and DNA fractions from the male line can cause females to develop male tendencies, characteristics and behavioral patterns.** Many communities are seeing an unprecedented number of new cases of homosexual interest by adults and children after receiving a vaccine. Across the USA, there are cases of adults complaining about poor sexual drive within weeks after administration of vaccines. Mothers are concerned that their male children who, within 3 to 10 weeks after vaccination, start playing with dolls and show unambiguous interest in, and inappropriate behavior with, their sisters. **The “attraction” issue between brothers and sisters has recently become a real problem, even among those families that protect their children from exposure to inappropriate materials.** “Gender confusion” is becoming a severe problem for many God-fearing people.

Vaccine-induced DNA mutations are different and more dangerous than either spontaneous DNA mutations or even targeted DNA modifications. In spontaneous mutations the DNA structure gets modified without the introduction of foreign DNA. In targeted DNA modifications for a specific genetic disease, DNA segments requiring modification are precisely targeted to achieve desirable changes. Clinical research demonstrates that even such planned DNA modifications have numerous life-threatening side effects due to millions of unknown interactions and the high complexity of human DNA structure. However, in the case of vaccines, random DNA fractions or even fully sequenced DNA debris from the cellular lining of embryonic stem cells from aborted fetuses are incorporated into adult stem cells. These are not carefully selected components from carefully investigated donors. These are random debris from aborted fetuses, many of whom are aborted due to genetic defects and have unknown diseases. **When these debris are incorporated into vaccine recipients’ DNA, they create numerous unidentified health issues that may not become apparent until decades later when DNA programs activate due to triggers or life events.**

Noticeably, over the past 2 years, numerous cancers which are typically rare in children have been increasing in our communities. It is not a coincidence since embryonic stem cells are very primitive and grow out of control, forming tumors one hundred percent of the time.

Over the past 10 years, our communities have experienced an increased number of deaths, an unprecedented number of *talmidim* unable to learn Torah, a growing number of couples unable to have children, a dramatic increase in those unable to marry due to retardation (autism and other neurodevelopmental disorders), changes in Jewish moral and spiritual essence, and never before seen homosexual tendencies including relations with sisters and brothers, etc., which can all be caused by the foreign DNA in the vaccines.

**Section 13 of vaccine package inserts clearly states that the vaccine hasn’t been tested for carcinogenicity, mutagenicity, or impairment of fertility.**

**We also now have epidemics of autoimmune diseases and seizure disorders. Yehuda Shoenfeld, Israeli doctor and Number ONE immunologist in the world, stated at the Vaccine Safety Conference that vaccines are a major trigger of autoimmune diseases.** The various adjuvants used in a majority of vaccines, not limited to aluminum salts, are known to have great seizure triggering capacity. As more and more vaccines are produced using human genome manipulation and/or virus genome manipulation technology, the greater the potential there is to damage the vaccinees’ own DNA, with unknown consequences. **Furthermore, several vaccines developed with different technologies may be given at one time, yet no studies have been done to determine the potential interactions and verified safety of such an approach.**

**HOW DID WE GET TO THIS ALARMING SITUATION?**

**Pharmaceutical companies spend billions of dollars on lobbying. This industry spends more money on lobbying than any other industry in the United States. Below are recent government policies and actions to support pharmaceutical companies in the manufacture, marketing, and distribution of vaccines.**

1. The Bush administration had a ban on research using embryonic stem cells. The ban was lifted by the Obama administration which also supported and funded embryonic stem cell research. This resulted in the development of new technology that uses inexpensive aborted fetal tissue as a medium upon which to grow vaccine antigens. The Obama administration also legalized gay marriages and used government insurance to pay for transgender medical and surgical procedures. Prison inmates could request hormones and transgender surgeries with the government providing funding to cover the costs. **A number of scientific papers discuss the use of embryonic stem cell technology to promote homosexual tendencies in people showing such interest, thus pointing to the link between the embryonic stem cell use in vaccines and the noticeable growth of homosexual tendencies in recently vaccinated people.**

2. Aborted fetuses became significantly cheaper and readily available after late term abortion became legal in New York State. Hillary Clinton and Bill DeBlasio were among the vocal promoters of late term abortions. **For purposes of harvesting embryonic stem cells and other research, “fetuses” are removed alive, when possible.**

3. In 1986, President Reagan signed **the National Child Vaccine Injury Act (NCVIA)** into law which **greatly limited the liability of pharmaceutical companies for vaccine induced injury and death.** There is no such limitation on liability for any other drug or product. (As per the New York Times, Reagan had “mixed feelings” about this bill.) **Despite this significant restriction on medical liability, over \$4 billion has been awarded for vaccine injury and death through a special claims process that was written into the 1986 law.** There is now only one way for vaccine manufacturers to be held directly responsible and sued for vaccine damage - if they commit fraud or fail to disclose dangerous ingredients. Disclosing the presence of fetal tissue and other harmful ingredients in vaccine package inserts protects the manufacturers from ANY vaccine liabilities and damages. Therefore, vaccine package inserts include in the list of vaccine ingredients the current cell lines, WI-38 (human female embryo cells) and MRC-5 (human male embryo cells), as well as the other dangerous and toxic ingredients.

**4. There are currently bill proposals in state legislatures intending to remove the requirement of parental consent in order to administer vaccines and other medications to children.**

It is an ancient wisdom that it is highly suspicious and likely dangerous if any government is pushing their agenda in such a strong way. Particularly alarming is the fact that, as a result of the 1986 law and in conjunction with increasing vaccine mandates, vaccine manufacture has become a highly lucrative market having almost no liability, guaranteed revenue, and free marketing, with minimal investment in safety research required. **Videos from the recent World Health Organization’s Global Vaccine Safety Summit clearly show “Top Doctors and Scientists” around the world admitting that they have NO SOLID SAFETY DATA and NO SOLID STUDIES on long-term adverse effects from vaccines.**

**All of the above demonstrate the grave danger that massive forced vaccination programs present and warrant a state of emergency in all God-fearing communities.** Please do not let the opportunity we now have to stop this scourge in its tracks go by. If we do not act now, it may soon be too late.

## Addendum

### Vaccine economics

Vaccines have become a major source of revenue for the pharmaceutical industry. There are now more than 1,000 new vaccines in the rapid development process that are being readied for large scale rollouts since, per the 1986 law, they are no longer responsible for conducting proper safety studies. In fact, the companies are discouraged from making any serious safety studies, since the only way they could be sued is if they failed to disclose the results of safety studies. But if there are no safety studies, they have ZERO liability. Simple and easy: No safety studies --- No liabilities. Therefore, only a few weeks or months of clinical trials are conducted with a very small number of people. However, some DNA mutations won't be triggered until decades after injection, causing sterility, cancer, low sex drive, infertility, fatigue, depression, and much more. **The major source of knowledge about damages is officially gathered through large scale human lab trials in which we adults and our children are their guinea pigs.** This is called post marketing data gathering or Mega trials, the results of which are disclosed by the companies, thereby shielding themselves from lawsuits.

### My personal family background and why I am committed to sounding this alarm

I come from a refusenik's background. **I still remember how my parents would tell me that though they were scared, the Jew should not be afraid to stand up for what he believes in, especially to protect other Jews from danger.**

I learned from my family that when the communists came to power in Russia a number of leading *rabbonim* mistakenly believed that they would be able to play games and negotiate with the communists. They thought that they would use the EV sections (that communists opened for poor Jews) to build German-like versions of *yeshivos* and *chederim*. Many *rabbonim* thought that they would be able to remain in the good graces of the communists because they were not against Jews, but against all religions. That gave them a pretext to mistakenly think that they could externally cooperate and comply with communist regulations, while secretly keeping the Torah ways. Some also believed that they could report uncooperative Jews to the government to make a *Kiddush Hashem*. We know well the tragic ending of those miscalculations.

The German Jews repeated the same mistakes. Even back in Spain they made those mistakes. One common denominator is evident in all these incidences, i.e., deep integration and cooperation with governmental structures resulting in ongoing misjudgment and reporting of other Jews to the authorities.

History proves that those of us who are in the position to educate and save people from worshipping vaccines and did not will be viewed as incompetent and short-sighted. They will be judged by the many thousands who are being damaged on daily basis by forced vaccinations. They will also be erased and forgotten from history like those who remained quiet during the incident of Kamtza and bar Kamtza which led to the destruction of the 2<sup>nd</sup> Temple, excommunicated Ramchal, burned the Rambam's books, and instigated and/or participated in other such horrific events.

**Today, we are facing a strong and suspicious pressure from numerous governments to force vaccinate our population. We have to carefully investigate vaccines and not quickly jump to defend a government position and try to accommodate the authorities.**

Some may say that there is no explicit prohibition in the Torah against a foreign DNA-caused mutation. Well, the Torah also does not prohibit the use of deadly poison cyanide in food and the Torah does not prohibit eating poisonous mushrooms or using dangerous drugs. But it is clear that the Torah requires us to protect our and our children's health.

It is simple common sense, that when something of this kind, like vaccines, is not thoroughly tested and proven 100% safe for individual health, it should be absolutely forbidden for any purpose in the Jewish community. The DNA mutation “side effects” created by vaccines are not studied at all and not disclosed to the public as even a possibility.

The use of aborted fetal cells is already being challenged in the federal courts, even by non-Jews. Until multi-decade studies will be conducted, proving them absolutely safe by independent researchers (not benefitting from the corrupted system), the administration of vaccines should ideally be forbidden, and certainly not recommended. This is clearly a health hazard, and not even a rabbinical issue anymore.

**Nazi Germany used vaccines in concentration camps to cause permanent DNA mutations to Jewish genetics as a part of Nazi medical experiments.** They were successfully able to create changes in twins and pregnant mothers, causing them to bear children with Down’s Syndrome, as well as cause sterility in hundreds of thousands of prisoners. **Interestingly enough, the USA started a eugenics project way before Nazi Germany came into play. Most of the German scientists were brought to the USA after WWII under the cover of special projects, which helped them to escape prosecution.**

The Nazi program was created in three stages:

1. Sterilization
2. Inability to get married due to retardation
3. Extermination

The first two steps we are seeing in our communities in full speed.

**It is very clear that we are becoming part of the same experiment... only this time ...voluntarily.** Sadly, for us, intense and powerful propaganda made us believe that we live in the *Medinah Shel Chessed*. So too, we were also led to believe that the government and pharmaceutical companies are working for our benefit.

I can no longer keep quiet. Everybody who speaks about the benefit of vaccines in one way or another benefits from vaccine revenue, either by getting money from a government agency, working in the industry, or receiving money from people who have financial ties to the industry. According to the Torah, a judge who benefits from the defendant by a small coin cannot judge the case. **Certainly, vaccine manufacturers, vaccinologists, and scientists, doctors, and others who benefit from vaccines should not be the ones entrusted with the testing of, or attesting to, vaccine safety. We all have to wake up before it is too late.**

Furthermore, the vast majority of medical doctors who support vaccination are neither educated and trained in vaccine research and development nor on the manufacturing processes involved in the production of vaccines. The standard medical school curriculum only provides basic information and administration schedules. Additionally, the majority of medical doctors do not possess a solid understanding of genetics that is so vital for comprehending the dangers involved when using modern vaccines. Only PHDs involved in genetic research possess bits and pieces of this vital information which is scattered across different research labs.

In the last year a number of *rabbonim* who were advocating vaccinations for their congregants and followers passed away within 6 months after receiving flu shots themselves. Giving blessings to mothers that their children will be fine, and it is even a mitzvah to vaccinate, simply does not work anymore for many, as the evidence of danger from vaccines is clear and unambiguous. Mothers cannot be fooled for long; after a few of their children are damaged by vaccines, they usually see the picture quite clearly.

Today the situation is such that if a child does not get damaged it is a sign of a true miracle. But I have seen much of the opposite in the last year. **Hundreds of seizure related emergency calls right after vaccinations in the last few months in Lakewood alone** provides quite scary confirmation. **Community leaders must open their eyes to the obvious.**

As I learned from my father of blessed memory, a person who remains quiet when he could have saved even one person from danger will be held accountable by Hashem and by the people themselves. So, I cannot and will not remain silent. I will continue, with *siyata d'Shmaya*, to educate every person I can about this grievous danger; I certainly do not want to be held responsible for keeping quiet.

Right before the Chernobyl reactor blew up, my father was asked to sign the papers stating that the reactor was safe. My father refused, even though he lost lots of money and was under pressure of losing his position. He told me that a Jew has to stand up for his beliefs, especially if he possesses knowledge that others do not. This approach saved my father and the rest of my family when the reactor blew up shortly thereafter.

*Boruch Hashem* there are several thoughtful community leaders who have been enlightened by my information and are working to determine the proper course of action. Let's not advise people to vaccinate in order to appease the government or from fear of antisemitism. Let's not sacrifice some, thinking it will help others. Let's work together and not be afraid to stand up for every child's safety, by clearly opposing any government actions until we know that they are safe. I have no doubt that those of us who will not protect our people from this tremendous danger and will not advise people to, by any means, abstain from vaccinations, will have our children's blood on their hands.

Please, at the very least, immediately halt any recommendations to vaccinate and contact me for more information. **I sincerely believe that true Torah leaders will comprehend the enormous immediate danger of the current situation.** Every day many more children have their DNA damaged, their blood spilled for questionable benefit of future protection, which they may not even live to see, *chas v'sholom*.

Let us not repeat the mistakes of the Russian Jews who hoped that they "could make it work with the communists".

Let us not repeat mistakes of the German Jews who thought that they "need to be law abiding citizens".

Let us not repeat mistakes of the Spanish Jews who thought that they could "publicly convert to Christianity and keep Judaism secretly".

Let us not allow Governments to use Machiavellian strategies to divide and conquer. Let us not allow ourselves to be split into small groups based on political, economic, and religious/vaccine beliefs. Let us not offer our children to be sacrificed on the altar of "demonstrating what good citizens we are" to the government.

Let us unite to face this danger! Let us stand up against and silence those leaders who publicly advocate reporting our brethren as "antivaxxers" to the government. ***Sinat chinam* destroyed the second Temple. Today we cannot remain silent and be misled by false leaders advocating *sinat chinam* against those who don't vaccinate.** Let us finally unite under the One and Only Almighty God.

**I ask every one of you to please call me. I will come with scientists and doctors who are willing to sit down and explain the details, despite the risk to their jobs, positions, and respect.** The danger is very clear and very time sensitive. We are living in a time of persecution and we are voluntarily subjecting ourselves like sheep to the slaughter exactly as before.... worshiping the governments under which we live. We made ourselves three idols - Medicine, Democracy, and Money and it is these three false gods that attack us from all sides. Vaccines are just a pretext for many more attacks to come in the near future, *chas v'sholom*.

**These words are coming from my heart. I pray that they enter the hearts of every Jew and non-Jew alike** and help us to understand the need to halt all vaccinations until thorough and independent studies are conducted. Damages from vaccines are real and true benefits have not even been proven, established, or guaranteed. We cannot base our decisions on belief in these false gods. With DNA technologies the very essence of a Human Being is endangered.
